Notes to physician

6. ACCIDENTAL RELEASE MEASURES

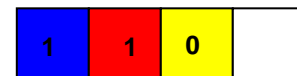

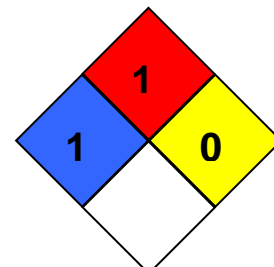
