**Notes to physician**

**5. FIRE-FIGHTING MEASURES**

**6. ACCIDENTAL RELEASE MEASURES**

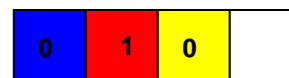

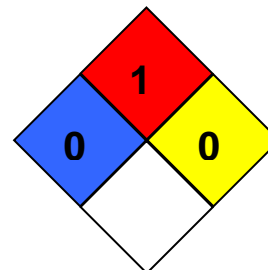
