**5. FIRE-FIGHTING MEASURES**

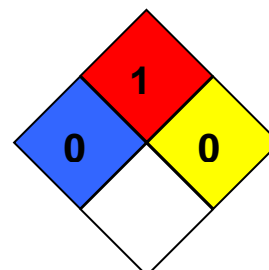
