Notes to physician

- Symptoms : Inhalation of process fumes and vapors may cause soreness in the nose and throat and coughing.
- Hazards : Dust contact with the eyes can lead to mechanical irritation.

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media : SMALL FIRE:
Use dry chemical, CO₂, or water spray.

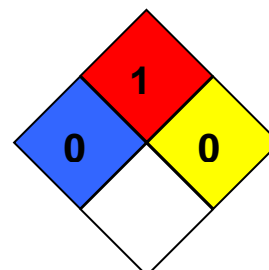
