**6. ACCIDENTAL RELEASE MEASURES**

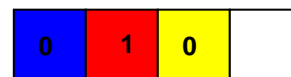

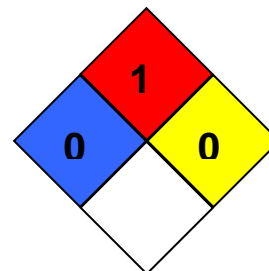
