**Notes to physician**

**6. ACCIDENTAL RELEASE MEASURES**

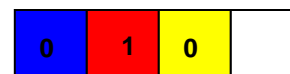

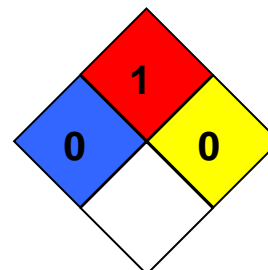
