**Notes to physician**

- Symptoms : Inhalation of process fumes and vapors may cause soreness in the nose and throat and coughing.

**5. FIRE-FIGHTING MEASURES**

### Precautions for safe handling

Equipment handling polymer should be conductive and grounded (earthed) and bonded.

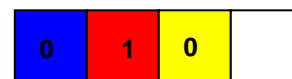

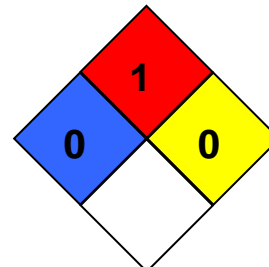
