Notes to physician

- Symptoms : Inhalation of process fumes and vapors may cause soreness in the nose and throat and coughing.

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media : SMALL FIRE:

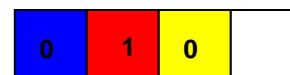

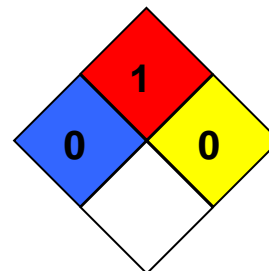
