4. FIRST AID MEASURES

Notes to physician

Symptoms	: Inhalation of process fumes and vapors may cause soreness in the nose and throat and coughing.

5. FIRE-FIGHTING MEASURES

Metal containers involved in the transfer of this material should be grounded and bonded.

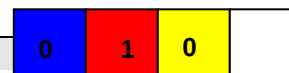

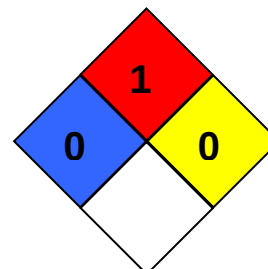
