Notes to physician

5. FIRE-FIGHTING MEASURES

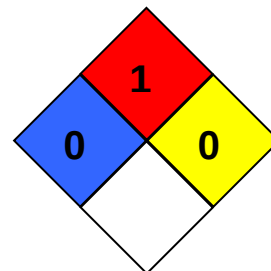
